THEY COME PRIMARILY FROM SHELTERS WHERE THEY ARE FACING IMMINENT EUTHANASIA. MUTTVILLE HAS ITS OWN CAGE-FREE FACILITY FOR NEW ARRIVALS, WHO UNDERGO MEDICAL TREATMENT AND ARE MATCHED AS SOON AS POSSIBLE WITH LOVING FOSTER HOMES. FOSTER CARE ALLOWS THE DOGS TO LIVE IN COMFORTABLE HOME SETTINGS RATHER THAN IN STRESSFUL KENNEL CONDITIONS. FOSTER FAMILIES CAREFULLY MONITOR THE DOGS TO LEARN ABOUT THEIR BEHAVIOR, HEALTH, TRAINING AND TEMPERAMENT, GATHERING INFORMATION THAT ENABLES MUTTVILLE TO MAKE INFORMED MATCHES WITH NEW FOREVER FAMILIES, AS THIS RESULTS IN A HIGH PERCENTAGE OF SUCCESSFUL FIRST-TIME ADOPTIONS.
